The bid/quotation must be submitted on official letter head of the bidder in the enclosed format Technical Bid (Annexure-A) and Financial Bid (Annexure-B) in separate envelop and signed by the Bidder. On the envelope Quotation for the supply "75 Inch Smart Board at DREE" must be clearly marked on Technical Bid (Annexure-A) and Financial Bid (Annexure-B). If the bid is not sealed and marked as required, the Procuring Entity shall assume no responsibility about its consequences including misplacement and premature opening of the Bid.
2. The Technical Bid will be open first by the competent committee on due date and time. If the bidder fulfill all the requirements as less down in the tender form, in his/her Technical Bid there only his/her financial bid will be opened.
3. If tender form is downloaded from the website- www.mpuat.ac.in a demand draft towards tender fee of Rs. 500/- is required to be attached with the technical tender bid. The DD should be draw in favour of DEAN CTAE, Udaipur.
4. Bid Security shall be 2% of the estimated value of subject matter of procurement put to bid or as specified by the State Government. In case of Small Scale Industries of Rajasthan it shall be 0.5% of the value of the quantity offered for supply and in case of Sick Industries, other than Small Scale Industries, whose cases are pending with Board of Industrial and Financial Reconstruction; it shall be 1% of the estimated value of Bid. Concession Bid Security shall be applicable for certain category of bidders as the rules in force.
5. Ernest money will only be attached in the technical tender bid of demand draft draw in favour of DEAN CTAE, Udaipur.
6. Quotation shall remain valid for acceptance for a period not less than 3 months after the deadline date specified for submission.
7. The rate quoted by the bidder shall be in Indian Rupees only and shall remain fixed for the duration of the contract and shall not be subject to adjustment on any account.
8. All taxes like GST Tax, etc. to be charged extra should be shown separately (along with their rate) failing which the rates quoted by the bidder shall be assumed to be inclusive of all taxes and levies.
9. All rates quoted must be FOR destination and should include all incidental charges.
10. The goods quoted should be as per the required specifications. Any deviations should be mentioned in the quotations.
